ROUTES TO TRIAL

From Interstate 295

Take Exit 28, Bath/Brunswick, Coastal Route 1. Continue on US 1 through Brunswick to Bath, Congress Avenue Exit. Turn right at end of ramp and take first right onto Congress Avenue. Proceed 1 mile. At first stop sign, turn left onto Oak Grove Road. Make an immediate left, in front of Domino's Pizza, onto Old Brunswick Road. The Bath Middle School is on the left.

From US Route 1, Heading South

Take Bath Exit for Congress Avenue; turn right at end of ramp. Proceed as above.
